

Body Worn Video Privacy Notice

What this Privacy Notice covers

Your privacy is very important to South Holland District Council. South Holland District Council is the Data Controller responsible for the personal information that may be captured on the body worn video camera's worn by officers of the Council.

Why we need your personal data

Your information will be used to provide evidence for the investigation and enforcement of antisocial behaviour and environmental crime. The legal basis for processing your data is Article 6.1(e) of the General Data Protection Regulations, as it is necessary for the performance of a task carried out in the public interest or in the exercise of official authority.

How your data is used

Body worn video cameras will assist in the investigation of anti-social behaviour and environmental crime and will therefore capture:

- victims of crime
- persons suspected of committing offences
- witnesses of crimes.

In addition, persons, unrelated to any specific interaction between council officers and any of the categories of individuals named above, may find their activities captured on a body worn video. To some degree, this is inevitable since a camera lens or microphone is non-discriminatory and captures what is seen or heard. A Data Protection Impact Assessment has been completed regarding the use of body worn video camera.

Body worn videos will not be routinely recording or monitoring on a continuous basis and will only be switched on when an incident is occurring or is suspected to occur.



Your personal data will not be shared with others without your consent, unless we are legally required to, for example for the prevention and detection of crime. The council reserves the right to release any footage of a violent offence if a person is convicted of said offence for the purposes of preventing future incidents.

How long the information is kept for

All data will be stored for 30 days before automatic deletion. Should images be needed for evidential purposes, they will be marked and retained in line with data protection retention periods.
