

SOUTH HOLLAND DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT) (AMENDMENT NO. 2) ORDER 2021

1. South Holland District Council ("the Council") in exercise of its powers under sections 32 and 35 of the Road Traffic Regulation Act 1984, the Traffic Management Act 2004 and of all other enabling powers and with the consent of Lincolnshire County Council under section 39 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.
2. This Order is supplemental to the South Holland District Council (Off-Street Parking Places) (Civil Enforcement) Order 2012 as amended by the South Holland District Council (Off-Street Parking Places) (Civil Enforcement) (Amendment No.1) Order 2019 ("the Original Order")
3. This Order shall come into operation on 1 April 2021 and shall be cited as the South Holland District Council (Off-Street Parking Places) (Civil Enforcement) (Amendment No.2) Order 2021.
4. Definitions set out in the Original Order shall apply in this Order.
5. The Original Order is hereby amended as follows:

PART I – GENERAL

6. In Article 2(5) (Interpretation) the following existing definition shall be amended as shown in underlined italics:

"parking bay" means any area of a parking place which is provided for the leaving of a vehicle and (*where provided*) indicated by markings on the surface of the parking place and not closed (in part or in whole) by a notice erected thereon by authority of the Council
7. In Article 2(5) (Interpretation) the following definitions shall be added:

"parking permit (physical)" means any physical permit issued by the Council or its appointed contractor(s) which permits the vehicle specified within the permit to park without charge at such parking place(s) and for such time period(s) as may be specified within the permit

"parking permit (virtual)" means any authorisation issued by electronic means by the Council or its appointed contractor(s) to the owner of a vehicle which permits that vehicle to park without charge at such parking place(s) and for such time period(s) as may be specified within that authorisation

PART 4 - EXEMPTIONS

8. Articles 5(2) to 5(4) shall be added as follows:

"5(2) The charges detailed in column 6 of the Schedule shall not apply to any vehicle parked in such parking place during such time period as may be specified in any valid parking permit (physical) which relates to that vehicle where the parking permit (physical) is displayed in a conspicuous position inside the windscreen of that vehicle or in the case of a vehicle not fitted with a front windscreen in a conspicuous position on the front or rear side of the vehicle."

"5(3) The charges detailed in column 6 of the Schedule shall not apply to any vehicle parked in such parking place during such time period as may be specified in any valid parking permit (virtual) which relates to that vehicle."

"5(4) The maximum period for which a vehicle may park detailed in column 5 of the Schedule shall not apply to any vehicle parked in a parking place for which a valid parking permit (physical) or a valid parking permit (virtual) has been issued where such valid parking permit (physical) or valid parking permit (virtual) permits the vehicle to park beyond the said maximum period in that parking place. Where the maximum period detailed in the parking permit (physical) or parking permit (virtual) has expired the person in charge of such vehicle shall be required immediately to remove the vehicle from the parking place or to display a valid pay and display ticket in accordance with Article 4(1)"

SCHEDULE

9. The Schedule to the Original Order shall be amended by the addition of the following details relating to a new Parking Place at Westlode Street, Spalding, which Parking Place is shown edged red on the plan attached to this Order:



Where column 6 in the table below does not contain any wording the details of charges that applied immediately prior to the date of this Order shall continue to apply:

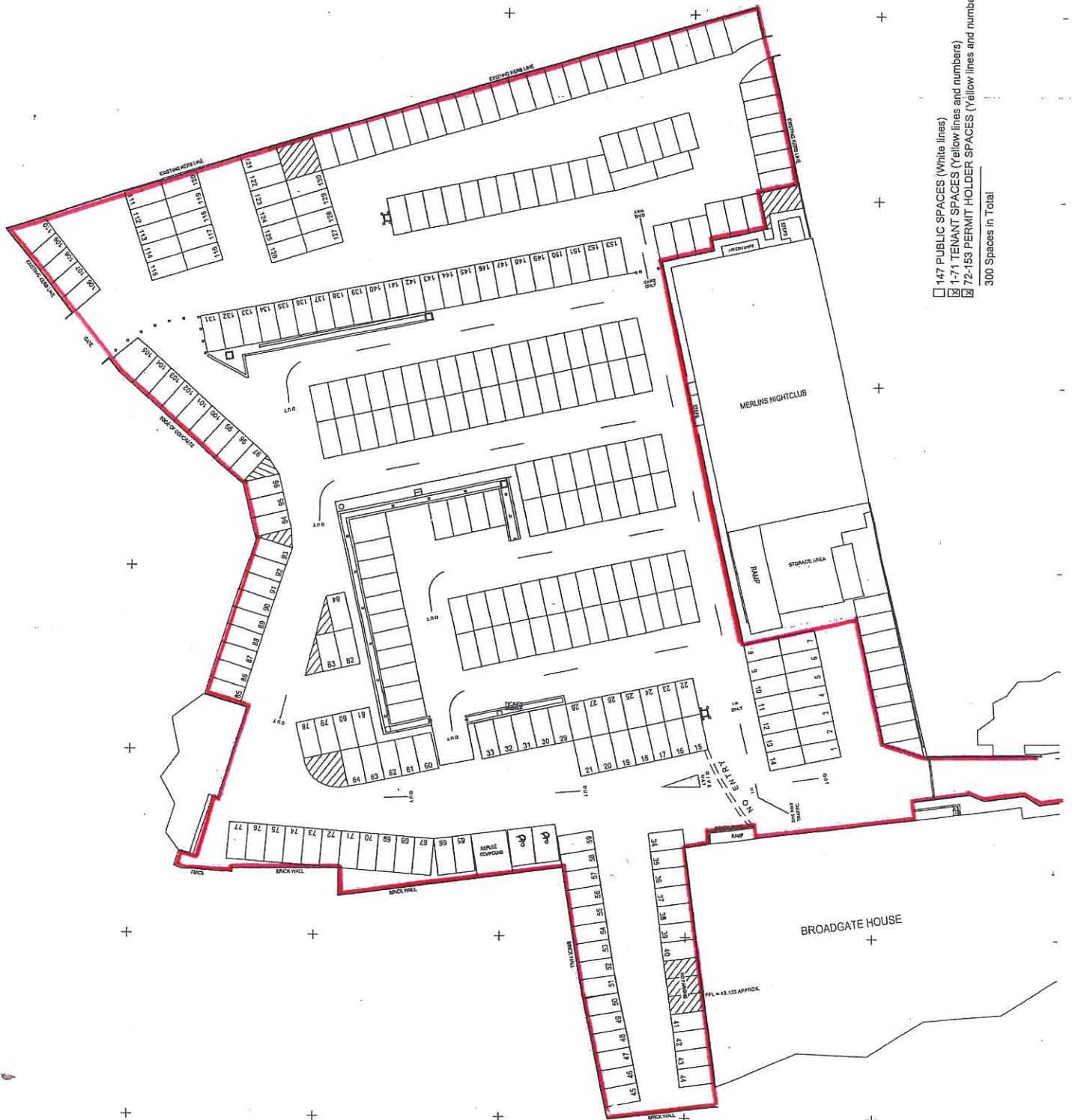
